### WEBSITE AGREEMENT

It is understood and agreed that **ALL MIAMI COMPUTER "Richard Singleton"** and **EAGLE INTERNATIONAL MEDIA** will hereby enter into this binding agreement on **February 20, 2016** for the purpose of **ALL MIAMI COMPUTER** building a custom tailored website and to include supplying said domain name and hosting as prescribed in this written agreement.

#### Scope of Service:

**All Miami Computer** will obtain a new dot com domain as desired and approved by client aka **EAGLE INTERNATIONAL MEDIA**

And which will be parked on the said web servers belonging to **All Miami Computer** for the term of one (1) year without any cost and or fees other than shown here in this agreement to the client known as **EAGLE INTERNATIONAL MEDIA**.

Custom tailored website will be built on a Word Press format containing all required content, images, video and or any other media that may be needed in order to publish a premium website. Client agrees to supply all images, and specialty data needed to be factual pertaining to the clients business.

**All Miami Computer** will supply the most rapid turnaround time possible for completion of the website pending the time span between receiving information from the client pertaining to their business, in most cases turnaround time for a Class A website constructed by **All Miami Computer** is three / four business days from the time payment is received.

#### Domain Name :

The domain name obtained on behalf of the client shall and will remain the sole property of the said client and at no time shall the client "\_\_\_\_\_ " be refused access to the domain name or its control panel far as long as he/she desires the use of the domain name.

#### Website Hosting:

The hosting supplied to the client "**EAGLE INTERNATIONAL MEDIA**" by **All Miami Computer** shall be free of any charges for the first year as a part of this agreement and shall continually run 24/7 without fail at a ratio of 99.% up time. The Client shall never be refused access to the website files or its control panel far as long as he/she desires the use of the hosting service.

Note: The Annual Hosting Renewal fee after the first year must be paid in advance twenty five (25) business days prior to the agreement expiring. Failure to renew may result in the hosting being suspended and or forfeited / removed from our servers. Client Will be Invoiced 45 business days in advance of the expiration date.

#### Website Deployment & Back Up:

Once the website is considered complete and running **All Miami Computer** will supply **EAGLE INTERNATIONAL MEDIA** the client with a complete backup of the entire website on a DVD to be kept in a dry place. This Back-Up will also contain all data bases, images, video if any to include the version of Word Press that the site was constructed on.

At no other place on your website shall our name appear and or be advertised.

**Annual Hosting Fee Increase:**

An Annual Increase in service may be required based on but not limited to:

- Size of content storage
- Required Monthly Up-Dates
- Bandwidth Consumption/Usage

We reserve the right to increase the annual renewal rate to not exceed ten percent of the current rate on the second year of hosting. After your first year of free hosting with ALL MIAMI COMPUTER, the actual renewal rate shall be \$450.50 which will include your Unlimited Hosting Package, Unlimited Emails, and Monthly Updates.
